

ALCOHOL

Possession of or drinking of alcoholic beverages is **PROHIBITED**.

DRIVING

Motorists are required to strictly observe speed limits. Proceed very slowly and with care through the parking area and on the access road. Traffic is **ONE WAY** to the **RIGHT** at the fork (counterclockwise).

WATCH OUT FOR CHILDREN AT PLAY!

FAMILY PARTIES

Groups of ten (10) or larger **MUST** be cleared by a supervisor **24 Hours IN ADVANCE**. Call the Cove at **860-379-8082** to do this.

All members of the party **MUST SIGN IN** with the supervisor on duty.

HOLIDAY PARTIES REQUIRE 48 HOURS NOTICE.

GUEST POLICY

Permit holders are responsible for their guest(s) and their behavior. They must accompany their guest(s) at all times. No guest(s) will be allowed in the area until the permit holder has arrived. Guest fees must be paid to the supervisor on duty at the start of each visit. Guests must register with the supervisor on duty. Guests must park as directed by the supervisor. Guest parking passes **must be displayed on the right side of the dashboard**. Guest parking passes must be returned daily to the supervisor on duty.

Guest Passes will be limited on the following **weekends**:

Opening (Father's Day) – July 4th – Closing (Labor Day)

(3 days' notice appreciated)

Overuse or abuse of guest privileges may result in loss of Cove privileges.

PARKING

Parking is permitted only in designated areas in a manner satisfactory to the supervisor on duty. Sticker must be displayed prominently on the right side of the windshield at all times.

No overnight parking.

RESTROOMS

Our restrooms are sanitized daily for your convenience. Parental supervision is necessary to ensure children utilize restrooms correctly and keep them clean. No potty chairs are allowed on the beach area. The beach and picnic areas must be kept clean; therefore, children are not allowed to use the area for toilet needs.

Washing of diapers, clothes, bodies or any items at the Cove is PROHIBITED!

CHILDREN UNDER 16 YEARS OLD

No one under the age of 16 is allowed at the Cove without adult supervision. Parents are responsible for children at all times.

Permits:

- Cove permits **MUST** be **purchased at the Beach** by **CHECK ONLY**.
- Permits must be affixed on the lower front-right windshield of the vehicle.
- Current car registration required!
- Proof of eligibility for resident sticker required. (*Otherwise a non-resident sticker may be purchased.*)
- A military discount is available with I.D. (not to be combined with other discounts)
- **Permits are NOT TRANSFERABLE.**
- **Permits may not be altered or reproduced in any manner.**
- There are absolutely **NO REFUNDS**

BOAT STORAGE

- Rental fee is \$100.00 per boat track space.
- Space rented to Resident Permit Holders first (Opening Week) then all Permit Holders.
- Requests made by filling out the boat storage rental form.
- Permits required.

Permit holders should read this brochure and become familiar with the Rules and Regulations. If you have any questions or concerns, please see the supervisor on duty.

RECREATION AREA REGULATIONS

The rules and regulations contained in this pamphlet are designed to ensure your safety and to protect the family atmosphere offered by the Cove. Please take a moment to review them.

GRILLS/FIRES

Grills are located in safe areas. If a barbecuing grill is brought in, it must be placed in a safe area (Not directly on a picnic table or bench). Fire buckets must be filled with water prior to starting the grill and used to extinguish all fires prior to leaving the picnic site. Ash and other burned material will be transferred to the appropriate receptacle by the Supervisor.

DO NOT EMPTY ASHES OR BRIQUETTES ONTO THE GROUND OR INTO A TRASH CAN.

BEACH GAMES

All beach games including but not limited to volleyball, baseball, and soccer, are up to the discretion of the lifeguards and the supervisor on duty.

FISHING

Fishing is not allowed inside the roped areas and is not allowed near the boat launch area.

GLASS CONTAINERS

Absolutely **no glass containers** allowed in the beach area!

MOTORIZED BOATS/PADDLE BOARDS

Motorized boats of any kind and paddle boards **CANNOT** be launched from or used at the Cove. Nor can they beach in the area.

PETS

No pets are allowed at the Cove. Pets are not to be left in parked cars.

PICNICKING

Picnicking is permitted in all recreation areas. Refuse must be deposited in the receptacles provided or removed from the property. Do **NOT** scrape food scraps onto the ground.

SWIMMING

Swimming is allowed only in the roped areas during the posted hours and when lifeguards are on duty. No swimming when the area is closed!

PERMIT REVOCATION

The Cove is a family-friendly environment. Inappropriate behavior, language and/or actions towards anyone are prohibited and may result in the loss of Cove privileges. Abusive behavior (of a non-physical nature) will result in a warning. Any further threat of or actual physical confrontation will cause the immediate loss of privileges and/or contacting the local authorities. Permits can be revoked.

Violations of the Cove Rules and Regulations and/or failure to comply with staff requests can and will result in the loss of Cove privileges - permits will be revoked.

The supervisor's or head lifeguard's decision is final for all activities including but not limited to swimming lessons, opening and closing times, games, use of the facilities guest privileges, boating policy and closing of the water for swimming

BOATING REGULATIONS

1. Persons wishing to launch their boats from the Cove **SHALL** have a **VALID** Cove Permit.
2. Permission to launch a boat **SHALL** be obtained from the Supervisor.
3. Signing "out" before launching and "in" when landing with the Supervisor is required. (Note: all boats launched from the Cove Shall return to the Cove.)
4. Only small boats that can be carried or caddied into the water **SHALL** be allowed (i.e. canoes, kayaks and sunfish).
5. No boat trailers are allowed. Boat caddies are allowed.
6. Coast Guard approved life preservers are required for each person in the boat.
7. All children in a boat **SHALL** be accompanied by an adult in the same or another boat.
8. No boats **SHALL** be kept overnight on the premises unless storage is pre-approved.
9. All boats launched from the Cove **ARE TO** be beached **30 minutes** prior to the closing of the area.
10. If the area closes due to inclement weather, all boats **SHALL** return to the launching area immediately.
11. Boating may be restricted in poor weather.
12. No boating is allowed in the swimming area.
13. No swimming from boats or in any unguarded area.
14. Boaters **SHALL** comply with MDC regulations.
15. Boating privileges or loss thereof are subject to the Supervisor's discretion.
16. Paddle boards are **NOT** allowed.

BOAT STORAGE

1. Space rented to Resident Permit Holders first (opening week), then all Permit Holders.
2. Boat storage shall only be allowed on the storage racks only; a space on the rack will cost \$100.00 for the season. A request can be made using the form provided by the supervisor.
3. Current Cove Permit **REQUIRED**.
4. Any person wishing to store a boat overnight shall sign the authorization agreement and waive the Cove Authority and Towns from any liability for loss or damage to their boat.
5. Persons storing boats overnight must provide their own locks.
6. All boats shall be removed from the Cove by the Closing Day.
7. The Cove is not responsible for any boats not removed by closing day.
8. Boat storage areas are available on a first come - first served basis.
