**ADVISORY COMMISSION ON CAPITAL EXPENDITURES**

BE IT ORDAINED, that creation of an Advisory Commission on Capital Expenditures is hereby authorized, said Commission to consist of three members, one regular member of the Board of Finance and two duly appointed or elected alternates to the Board of Finance. The purpose of the Commission shall be to determine what the capital needs of the Town will be for the five year period following each July 1st in a timely manner so as to allow review of the plan presented at each annual budget hearing and budget meeting. Capital programs to fall within the jurisdiction of the Commission shall include purchases of three thousand dollars (\$3,000) or more for equipment having a normal useful life in excess of five years, anticipated purchase of real estate for use by any Town department excepting fire department, libraries or cemeteries which are separate corporate entities.

The term of office for Commission members shall coincide with their terms of election or appointment to the Board of Finance.

**CAPITAL EXPENDITURES COMMISSION**

BE IT ORDAINED: that the ordinance relating to the Capital Expenditures Commission be changed to read, said Commission to consist of four members, one regular member of the Board of Finance, one member of the Board of Education, one member of the Planning and Zoning Commission and the First Selectman. The purpose of the Commission will be the review of capital needs of the Town for presentation to the Board of Finance and to the Town budget hearing and budget meeting. Capital programs shall include purchases of five thousand dollars (\$5,000.00) or more which have normal useful life in excess of five years. The Commission will report to the Board of Finance twice a year – September and February – with its priority list.

**ADVISORY COMMISSION ON CAPITAL EXPENDITURES**

BE IT ORDAINED: that the ordinance creating the Advisory Commission on Capital Expenditures be changed to authorize the Boards of Education, Finance, and Planning and Zoning to appoint their representatives to the Advisory Commission on Capital Expenditure and that the ordinance will read:

That creation of an Advisory Commission on Capital Expenditures is hereby authorized: said Commission to consist of 4 members, one member of the Board of Finance, one member of the Board of Education, one member of the Planning and Zoning Commission, said Boards to appoint their own representatives to the Advisory Commission, and the First Selectman. The purpose of the Commission shall be to determine what the capital needs of the Town will be for the five year period following each July 1st in a timely manner so as to allow review of the plan presented at each annual budget hearing and budget meeting, and report to the Board of Finance every September and February with a priority list. Capital programs to fall within the jurisdiction of the Commission shall include purchases of Five Thousand Dollars (\$5,000.00) or more for equipment having a normal useful life in excess of five years, anticipated purchase of real estate for use by any Town department excepting fire departments, libraries or cemeteries which are separate corporate entities. The terms of office for Commission members shall coincide with their terms of election or appointment to their respective boards.
